# Strategic Plan Results

As we conclude the second year of our strategic plan, we reflect on the strategies that shaped our priorities and guided our execution. In collaboration with our investors and community partners, these strategies enabled our team to advance the plan's vision, strengthen the regional economy, and enhance the overall competitiveness of Miami-Dade.

## I GROW THE ECONOMY

- Delivered record-breaking business development results, closing 55 projects, creating over 3,000 direct jobs, and securing \$1.2B in capital investment—the strongest capital investment year in Beacon Council history
- Improved operational efficiency and responsiveness, by restructuring the Business Development team and making it faster and easier for businesses and partners to connect with the Beacon Council through enhanced scheduling and new digital AI enabled tools, supporting timely project execution
- Restructured the Industry Advisory Councils—Aviation, Technology, Finance, Life Sciences & Healthcare, and International—around shared pillars of innovation, workforce development, and business attraction, while also aligning industry leaders on emerging opportunities such as eVTOL, data infrastructure, and fintech to support long-term growth

## II CHAMPION MIAMI

- Launched a new website that is tailored specifically towards investors, site selectors and companies looking to grow and expand in Miami
- Activated DCI, a nationally recognized leader in place-based marketing for economic development organizations, conducted a strategic overhaul of The Beacon Council's marketing function, refining brand positioning, and built a modern, scalable outreach strategy
- Beacon surveyed 50 national consultants on Greater Miami's competitiveness as a business destination. The results revealed that 70 percent had considered Miami-Dade for client projects but overall perceptions of the region's business climate have declined since 2023

### III INVEST IN PEOPLE

- Talent Bridge is the Beacon Council's industry led effort to address the talent continuum in Miami, receiving support from over 200 companies and Beacon's first-ever legislative appropriation of \$1 million to support this effort
- Partnered with Teach for America and the Miami-Dade Economic Advocacy Trust to highlight trends in workforce, and education in Miami
- The Academic Leaders Council (ALC) held a luncheon that included the Helios Foundation to learn about Florida's Future Billions report. Closing gaps in college enrollment and completion, improving readiness by 10%, and raising degree attainment 20% could result in over \$8.38B in economic activity

### III TRACK AND DELIVER

- The Miami-Dade Beacon Council's Advisor is a cutting-edge, AI-driven virtual assistant designed to streamline lead qualification and provide tailored economic development resources to businesses exploring opportunities in Greater Miami
- The Beacon Council was awarded a \$250,000 Defense Reinvestment Grant from the Florida Department of Commerce. This funding will help veteran-owned businesses and other military-dependent enterprises diversify their revenue streams by providing greater access to critical information, expanding business networks, and offering support in securing procurement opportunities
- A Quarterly Report with insights into the work we are doing and the overall state of the economy is published and distributed to all stakeholders

### IV SHAPE THE FUTURE

- Engagement through more programming and investment – private investment has increased by 57% during the past two years. This does not include grants, legislative appropriations and event sponsorships have diversified the organization's funding sources
- The cities of North Miami and North Miami Beach became the first cities to formally join The Beacon Council, setting the tone for broader collaboration across the county
- New engagement opportunities from a quarterly speaker event, quarterly business development updates, the annual meeting, key ceremony and the return of the Beacon Awards. The latter returned in the new fiscal year but the groundwork occurred during FY2024-25. This was the return after a five-year hiatus

# Highlights

## 01

During the first quarter the Beacon Council received its first ever grant to support and advance the connections to the business and military community.

Additionally, we hosted our second annual **Founders Summit** during Art Basel.

The Beacon Council joined forces with local leaders during Miami-Dade Days and conducted three advocacy trips to Tallahassee. Senator Ana Maria Rodriguez and Representative Demi Busatta sponsored Beacon's Talent Bridge legislation.

The Annual Meeting and **Key Ceremony** drew record participation and spotlighted the strength of the economic development pipeline.

SelectUSA Brazil Roadshow 2025, promoting Miami-Dade's business advantages across multiple Brazilian cities, generating strong leads in manufacturing, pharmaceuticals, and tech through 60+ one-on-one meetings and 13 qualified leads generated.

The Beacon Council **Annual Board Retreat** focused on three key themes: Talent Bridge, marketing, and future-proofing the organization. This full-day session included insights into the philanthropic scene in Miami, an overview of the Perception Survey and insights on the 2025 Legislative session.

**Q4**  
Opportunity Miami, powered by the Beacon Council Foundation, won the Bronze 2025 Excellence in Economic Development Award from the International Economic Development Council in the Postsecondary Education Partnership category. The honor recognizes the work of our **Academic Leaders Council**, a collaboration between Miami's largest educational institutions and Miami-Dade County Public Schools.

The Last Board meeting of the year included passing the budget, seating a new board, and providing insights on Carnival Cruises selecting Miami for its consolidated headquarters where all the landside operations will be under one roof.



# Business Visitation Summary

Every year, The Beacon Council visits with a wide swath of businesses in the region. These make up targeted industry sectors, past companies that have invested in Miami and companies that need assistance. This past year, these efforts have been redoubled, with 328 companies interviewed to learn more about their future plans, barriers, and opportunities in the region, as well as the key advantages and disadvantages of doing business there.

These visits also allow us to help companies grow and expand in Greater Miami rather than pursue opportunities in other communities.

# Key Accomplishments

**Business Development delivered a landmark year in FY24–25, closing 55 projects, generating \$1.2 billion in capital investment and over 3,000 new jobs—the strongest capital investment year in Beacon Council history and the second-highest year for projects and jobs in the past decade.**

**We also visited the most local businesses on record (328 companies). The year also marked meaningful progress in strengthening the business development platform, including improved engagement through enhanced booking systems and advancement of long-term initiatives such as the Strive305 transition and regional collaboration—positioning the organization for sustained, higher-impact growth.**

In December of 2024, The Beacon Council was awarded a \$250,000 **Defense Reinvestment Grant** from the Florida Department of Commerce. This funding will help veteran-owned businesses and other military-dependent enterprises diversify their revenue streams by providing greater access to critical information, expanding business networks, and offering support in securing procurement opportunities. The Department of Commerce increased the grant amount twice resulting in over \$800,000 being awarded.

Backed by a \$1 million appropriation in Florida's FY25 budget, **Talent Bridge** is moving from concept to execution—advancing a critical solution to Miami-Dade's high-skill talent shortages. Designed in response to employer demand, the platform connects people to opportunity and companies to talent with greater speed, precision, and long-term impact. We extend our sincere thanks to Governor Ron DeSantis for signing this appropriation into law and to Senator Ana Maria Rodriguez and Representative Demi Busatta Cabrera for their leadership in sponsoring this initiative. Their commitment reflects a growing statewide recognition: workforce readiness is economic readiness.

In 2025, **Opportunity Miami**, a program of the Beacon Council Economic Development Foundation, was named a Bronze Honoree of the International Economic Development Council (IEDC) Excellence in Economic Development Awards. The recognition highlights the Academic Leaders Council (ALC)—a first-of-its-kind collaboration uniting Miami-Dade County Public Schools and the presidents of Miami-Dade's major colleges and universities to align education with industry demand. Since its relaunch in 2022, the ALC has become a cornerstone of the County's talent strategy, convening leaders quarterly, engaging the public through annual forums, and publishing thought leadership focused on building a future-ready workforce.

# 1985 1995

## THE BUILDERS

It began with a bold idea: Miami could compete with the world. Visionary leaders united to rebuild in a decade marked by challenge and change, anchored by partnership, purpose, and possibility.

**The visionaries of this era didn't just build an organization; they built a platform for Miami's future.**

### 1985

The Miami-Dade Beacon Council was founded to unite businesses and government and attract jobs, investment, and opportunities to Dade County.



### 1986

The Beacon Council Economic Development Foundation is created as a research hub funded by the State of Florida and the Knight Foundation. Launches first campaign: "Miami Has What the World Wants."



### 1990

Future Governor Jeb Bush chairs The Beacon Council and establishes Team Miami, a private sector engine for corporate recruitment.

### 1992

After Hurricane Andrew, the Beacon Council Economic Development Foundation deploys \$11.3 million in emergency bridge loans, helping 558 companies rebuild and reignite the local economy.

### 1995

The Beacon Council secures the relocation of U.S. Southern Command from the Republic of Panama and supports the Summit of the Americas, placing Miami at the center of hemispheric trade and diplomacy.

## THE INNOVATORS

1996 — 2005

As technology reshaped the world, Miami claimed its place at the crossroads of innovation and trade. This was the decade when creativity met connectivity — and a city once defined by geography became defined by ideas.

### 1998

The Beacon Council launches Internet Coast (iCoast), positioning South Florida as a global tech and telecom hub. The effort leads to the Network Access Point of the Americas, connecting Latin America to the digital world.

### 1999

The Beacon Council launches "Make It Miami," a \$6 million global marketing campaign showcasing Miami's business strength and lifestyle appeal.

### 2003

The Beacon Awards and Jay Malina Award debut, celebrating companies and civic leaders driving progress across Greater Miami.

### 2005

The Beacon Council retains Burger King's global headquarters, reaffirming Miami as home to iconic international brands through a historic incentive package.



## THE CONNECTORS

In this decade, Miami didn't just open doors it built bridges. Between continents and communities, ideas and industries, ambition and access, the city stepped fully into its role as the gateway where the world meets.

**Miami built physical, economic, and human bridges. In the years to come, those bridges would become the lifelines of a city built to connect the world.**

### 2008

The Beacon Council launches "Miami: Where Worlds Meet," cementing the city's global brand as a crossroads of culture and commerce.



### 2010

The Beacon Council helps Visa expand in Miami-Dade, retaining 250 jobs and creating 366 new ones, a powerful vote of confidence in Miami's global economy.

### 2012

The Beacon Council Economic Development Foundation relaunches "One Community One Goal," aligning business, education, and government around a shared vision for Miami's future.



### 2014

PortMiami Tunnel opens, a game-changing infrastructure link connecting Miami's economy directly to global trade routes.

### 2015

The Academic Leadership Council was formed along with the launch of the Talent Development Network.





## THE RESILIENT

From global disruption emerged local transformation, as Miami turned challenge into momentum and resilience into reinvention, proving its ability to lead in moments of change.

**Through every challenge, Miami proved resilience is more than recovery; it's reinvention. And in that reinvention, we discovered our power to lead.**

### 2018

Miami was one of two finalists from Amazon's national search for HQ2.

### 2020

Began launching several pandemic-related recovery efforts to help businesses and residents cope with the fallout from COVID-19.

### 2021

Building on recovery efforts, The Beacon Council launches SBX, a small business initiative, and Miami Community Ventures, empowering the underemployed, returning citizens, and heads of households.



### 2023

The Beacon Council delivers a record year with 5,700 new jobs and \$650 million in investment, fueled by Kaseya's expansion and a surge of tech innovation redefining Miami's skyline and workforce.



### 2025

At 40 years strong, The Beacon Council celebrates \$1.2 billion in new capital investment, 3,000 quality jobs, and securing \$1 million from the Florida Legislature to launch Talent Bridge, a ground-breaking workforce initiative that connects employers, educators, and local talent, advances skills-based hiring, and ensures Miami's residents are prepared for the jobs of the future.
